## Renewal Changes in 2016

Starting next year ALL licenses must be renewed in June. Starting July 1, 2016, a license shall expire on the first day of July. A license shall be renewed on June 1 through July 1 of each year. Any license postmarked after July 1, 2016, will be assessed a \$25 late fee per license.

To help with this change the Board will be offering online renewals. There will be a link on our website (<http://barbering.ky.gov>) that will take you to the online renewals.

The Kentucky Board of Barbering is an independent agency of Kentucky State Government. The board has complete supervision over the administration of the provisions of chapter 317, relating to barbers, barbering, barber shops, independent contract owners, barber schools and the teaching of barbering.

It is the responsibility of the Board of Barbering to protect the health and safety of the public or to protect the public against misrepresentation, deceit or fraud in the practice or teaching of barbering.

## Report unlicensed barbering

A current Kentucky Barber License is required to practice barbering within the Commonwealth. Persons practicing unlicensed pose a safety risk to the public and financially impact legally licensed barbers across the Commonwealth of Kentucky. If you observe any illegal activity, please contact our office.

## Sanitation

Proper sanitation practice is the key to protecting the public. A new neck strip is required for each patron. Towels are not to be used on more than one patron. Clean towels are to be kept in a clean closed cabinet. Hair cloths/cutting capes should be clean and free of stains.

## New Sanitation Law

All tools and implements are to be stored in a properly functioning UV sanitizer. They should be cleaned and sanitized between uses and stored to maintain the sanitation. The UV sanitizer box is replacing the formaldehyde tablets.
